To qualify for this cover, a prior request, written cost approval by Helsana, a medical prescription and a physician/therapist recognised by Helsana are required. The services are limited to a maximum of CHF 3,000 per calendar year from TOP/OMNIA or CHF 4,500 per calendar year from COMPLETA. Services covered abroad are marked with a (\*). Under COMPLETA EXTRA/COMPLETA PLUS, the excess under COMPLETA will be covered in the amount of 25%.

Please note: For some courses of treatment, the indications, number of paid sessions and/or the maximum cost per treatment are fixed. We will be happy to provide you with more details about the specific scope of benefits. The phone number is printed on your insurance card.
